




• \$1 million in funding to micro and small businesses and non-profits who are located in eligible construction zones with grants ranging between \$5,000 and \$35,000.

### **Grant Awards & Limitations**

- Funds must be used for business-related expenses, including payroll/healthcare benefits, contract labor, working capital, business rent or mortgage payments for business property, supplier payments, machinery and equipment, critical operating expenses, utility payments for business locations (does not include personal residence).
- Qualified applicants will be eligible for up to 100% of the difference in net income in 2024 compared to 2023.
- Grant awards are limited to one per business at each physical address within the City of San Antonio. Grant applicants with multiple businesses in eligible construction zones are eligible to receive more than one grant award if the applicant can financially differentiate between the businesses (e.g., provide separate financial statements for each business) and each business meets all of the eligibility criteria.

### **Program Qualifications**

All applications will be reviewed based on stated and verified business information.

- Have a minimum of \$10,000 gross sales in 2023.
- Applicant has owned the business and has a formation date on or before 1/1/2023.
- Be a retail or service business that requires customer foot traffic for operations.
- Meet the <u>SBA Size standard</u> for small business based on your 6-digit NAICS code.
- Demonstrate net profit/loss in 2023 that is at least \$5,000 greater than net/profit loss in 2024. Net profit/loss is based on Line 29 of Schedule C, Line 30 of 1120, Line 21 of 1120S or Line 22 of 1065, Line 19 of 990 or Line 18 of 990-EZ
- Be currently in operation and not have filed for bankruptcy during duration of application process.
- Be located within an eligible construction zone and remain open for one year from date of grant award. Check if business address is located within a construction zone at our COSA Construction Zone Check.
- Non-profits must have revenue from ticket sales for in-person attendance at a series of events or programs

- Not be in the following categories: gambling/gaming businesses, franchisors, sexually oriented businesses, payday & auto loan providers, liquor stores and businesses in which a City employee or officer has a financial interest, as defined in Sec. 2-53 of the City's Ethics Code. - 2023 and 2024 filed Business tax return to determine net revenue and prove losses; if 2024 tax return has not yet been filed, a year-end financial statement may be accepted
- Driver's license; or government-issued photo identification
- Most recent business utility bill
- Q1 2025 Form 941 or Q1 2025 payroll report
- Most recent business bank statement. LLC, Corporations and partnerships will also submit a grant resolution. Template provided in application.
- List of board of directors (non-profits)
- 501c3 determination letter (non-profits)

# **Scoring Methodology**


Grant funds will not be awarded on a first-come, first-served basis. Applications will be assessed and scored based on the three components below. The maximum score is 100. Applications with the highest scores will be reviewed, approved, notified and funded first, if eligible.

- Prior assistance received
- Net Revenue loss
- Time in Business relative to duration of construction project

# The City of San Antonio Accelerate Recovery Construction Grant

- \$120,000 in funding to micro and small businesses who are located in eligible construction zones with grants of \$5,000.
- All completed applications will be reviewed based on stated and verified business information
- The grants will be in the amount of \$5,000 to eligible small, for-profit businesses

### **Grant Awards & Limitations**

#### Eligible Expenses:

- Materials and/or service of Exterior or Interior Painting
- Service of Exterior Power washing/sand blasting
- Purchase of Outdoor furniture or Outdoor cooling/heating systems (excludes Installation Service)
- Purchase of Interior tables and/or chairs (excludes Installation Service)
- Materials and/or service of Landscape (planting of greenery, Xeriscape landscaping)
- Materials and/or service of Exterior or Interior Installation/upgrade to lighting
- Installation of energy/water efficient appliances (light fixtures, toilets, sinks, kitchen equipment) (excludes purchase of appliances)
- Materials and/or service of Repair/Installation of Stucco, Stone, or Masonry on exterior of building
- Materials and/or service of Repair/Upgrade of windows, window framing, doors (no installation of burglar bars)
- Repair and/or installation of signage.

- 5 clear photos of area to be improved
- Most recent business bank statement
- Notarized letter of acknowledgement from property owner authorizing improvements, if business location is leased
- Detailed description of intended use of funds totaling at least \$5,000, including quotes from contractors or equipment retailers

- \$80,000 in funding to micro and small businesses who are located in eligible construction zones with grants of \$2,000.
- All completed applications will be reviewed based on stated and verified business information
- The grants will be in the amount of \$2,000 to eligible small, for-profit businesses
